AGENDA ITEM NO.7

Payment of Arrears of State Share By District Red Cross Branches as there is no shortage of Funds in District Branches.

As per provision under Section 9 of the Constitution of India, 30% share of collections done by District Red Cross Branches are to be paid to State Branch. Out of this 30% share,15% is to be submitted to the National Headquarters.

The District Branches were requested at the level of Secretary, Indian Red Cross Society, Punjab State Branch, and then Principle Secretary to Governor, Punjab to send due Share to the State Branch for further remittance to National Headquarters. But the Districts have been deferring the payment of such arrears on the plea that there is shortage of funds in the districts.

But now the financial condition of the districts has much improved as the State Govt. in compliance with the direction of Hon'ble Punjab and Haryana High Court in CWP No. 18396,Resurgence of India Vs Union of India has reimbursed substantial amount to the District Red Cross Branches vide letter No. 11/39/2011-A-2/12265 dated 12-09-2014 (Annexure 'F').

Thus the financial position of the District Red Cross Branches have much improved and they are now in a comfortable position to remit the share of State Branch and National Headquarters and fulfill the constitutional obligation immediately.

The DCs-cum-President of District Red Cross Societies may be advised to pay the share of State Branch/ National Headquarters immediately.

His Excellency observed that the Presidents of District Red Cross Societies are Deputy Commissioners who is considered the most important officer of the District. Therefore, the **Presidents** ofthe District Red Cross Societies should show their effectiveness and ensure that there is no shortage of funds in the District Red Cross Societies. HE emphasized that the payment of the share of the State Branch may be cleared immediately.

The matter will be taken up with the Deputy Commissioners-cum – Presidents of District Red Cross Societies for the payment of State share after circulation of a copy of the Proceedings to them.

AGENDA ITEM NO. 8

Adoption of Uniform Rules for District Red Cross Branches as per Model Constitution

In order to streamline the functioning of District Red Cross Branches, there is a need to formulate and adopt uniform rules for this purpose by all district branches.

Vide Agenda item No.9 of the Managing Body Meeting dated 11th April,2013, it was decided that copy of State Branch Service Rules 1996 be circulated to all District Branches for favor of comments, as to whether they are willing to adopt these Rules.

After, considering the comments of district branches a committee was constituted involving senior and experienced officers from District Branches to decide the applicability of uniform Rules.

In compliance of Managing Body decision, the committee was constituted as follow:-

The aforesaid committee proposed the draft Rules which are enclosed as Annexure 'G'

As per Rules 24(ii) under Penalties and Appeal Clause, it was recommended by the committee that appeal of the order of President shall lie with Commissioners of respective Divisions. Now, after reconsideration, it has been recommended by the Committee vide letter No. 384/RC dated 12.1.2016 (Annexure G-1) that "since Divisional Commissioners are not having direct role in the functioning of the District Red Cross Branches, it is therefore suggested that the appellate power may be entrusted to Secretary, Indian Red Cross Society, Punjab State Branch, Chandigarh". These rules are submitted for approval under Section 35 of Model Constitution for District Red Cross Branches & subsequent amendment to these rules subject to

Approved.

It was observed by the Chief Secretary to Govt. of Punjab that Divisional Commissioners have relatively less workload and they should be suitably associated with the Red Cross activities at district level. also observed was that being more and senior experienced in such appellate related matters, they may be made the Appellate Authority under these Rules.

It was also decided that the Divisional Commissioners may be made ex-officio members of the Managing Body of State Branch.

The Deputy Commissioners will take suitable steps to involve their respective Divisional Commissioners in the Red Cross activities at Districts level.

The State Branch may initiate the process required for this purpose.

To bring improvement in the working of administration of the Society, it is proposed to incorporate/amend the Indian Red Cross Society, Punjab State Branch, St. John Ambulance Punjab State Centre, State Red Cross Hospital Welfare Rules, 1996 as amended from time to time.		
The following incorporation/amendments in Service Rule of Indian Red Cross Society, Punjab State Branch are necessitated and proposed for favor of approval:-		
1. (a) <u>Deputy Secretary Through Direct Recruitment.</u>		
There are two posts of Deputy Secretaries in the Society Rules. Out of two posts, one is required to be filled up by promotion and the second post is to be filled on contractual basis on consolidated honorarium fixed by the Society from time to time. But, no educational qualification, experience and age limit has been laid down to fill up the contractual post of Deputy Secretary so far. For the sake of consistency and transparency and to check the arbitrariness the following eligibility requirements are proposed:-	Approved.	No further action is required.
"Any retired/non retired Class A Officer having minimum experience of 7 years in any State/Central Govt./Board/Corporation.

Served at least for 02 years as Under Secretary of State Govt./Board/Corporation.

07 Years experience of working on either or both the posts of Superintendent Grade-I and Superintendent Grade-II. Out of which at least 5 years experience shall be on the post of Superintendent Grade -1		
Age - 62 years of age as on 01 January of the recruitment year.		
Age 62 years of age as on 01 January of the recruitment year.		
(b) <u>Deputy Secretary Through Promotion.</u>		

The qualifications & eligibilities required for the post of Deputy Secretary by promotion has been changed from time to time. In 2008, the eligibility for this post was made 04 years service as Accounts Officer & Senior Field Officer as these posts are considered senior posts to the other posts like Publicity Officer, State Training Supervisor, Field Officer, Superintendent-Grade - II and Social Welfare Officer for which the eligibility was 10 years of service.

In 2013, the requirement of experience was changed to 08 years as Accounts Officer, Senior Field Officer & Superintendent Grade -1 but no change was made for the posts of Publicity Officer, State Training Supervisor, Senior Field Officer, Superintendent Grade-II and Social Welfare Officer.

Therefore, it is proposed that experience required for senior categories of Officers i.e. Accounts Officer, Senior Field Officer & Superintendent Grade-1 may be reduced to 05 years instead of 08 years because it would be a more rational and balanced decision under circumstances. This will also provide a reasonable opportunity for promotion to the concerned categories of employees and will help to remove the sense of stagnation and frustration which will also be in the public interest. In the light of situation explained above, the decision taken in the Managing Body Meeting on 11-04-2013 needs to be revisited & re-amended as under:-

<u>For</u>: "From amongst Accounts Officer, Senior Field Officer and Superintendent Grade -1 having 8 years experience as such and having proficiency in English both in writing and spoken to be adjudged by the Departmental Selection Committee."

Read: "From amongst Accounts Officer, Senior Field Office and Superintendent Grade -1 having 5 years experience as such and having proficiency in English both in writing and spoken to be adjudged by the Departmental Selection Committee."

(c) <u>Assistant State Training Supervisor</u>:

The educational qualification and experience for the post of Assistant State Training Supervisor laid down in the Society's Rules is so somewhat high as a result of which the office is unable to find suitable candidate of this educational qualification and experience inspite of advertisements and the post has remained unfilled. Hence, the following amendment is proposed in the present Rules:

(e) <u>Regularization of the Post of Safai Sewak on compassionate grounds:</u>

Smt. Vidya Devi Safai Sewika who was working in the Indian Red Cross Society, Punjab State Branch was expired on 25th January, 2010. After her death, her son Shri Vikas Kumar submitted an application for appointment as Safai Sewak on compassionate ground on priority basis. But he could not be given a regular appointment due to the reasons that the post of Safai Sewak was converted into contractual post. As a result of which Shri Vikas Kumar serving on contractual basis for the last 6 years on D.C rate. In this way, Shri Vikas Kumar has been denied the relief of employment on compassionate ground (priority category) but he has been making repeated requests for the appointment on regular basis.

A Sub Committee of the experienced officials of the Punjab State Branch after examining his application has recommended that the case of Shri. Vikas Kumar deserves to be considered sympathetically for regular appointment and also recommended that the matter be placed before the Managing Body Meeting as Agenda item for according approval for the regularization of the post and for the appointment of Shri Vikas Kumar on regular basis. Hence, the said item is placed before the Managing Body for consideration and approval.

The matter was discussed and the unanimously House authorized His Excellency to take appropriate decision on file and no need to bring the case to Managing **Body** again.

The case will be put up to His Excellency with the appropriate proposal.

AGENDA ITEM NO. 10

Policy for Renting/Selling out of Red Cross Property (Annexure "J")

The Punjab Govt. vide its letter No. 4/77/2014-3f 4/1524 dated 30.09.2014 asked the State Branch of Indian Red Cross Society to draft a policy for renting/selling out of the Property of District Red Cross Branches. The Punjab Govt. did this in compliance of the CWP 18396 of 2007.

2. The State Branch took the following steps to work out the draft policy:-

It was also decided that in case no bid comes forward for the minimum reserve price assessed by the PWD then in that The policy/instructions in this regard will be sent to the Deputy Commissioners & Presidents of the District Red Cross Branches

- (a) All the District Red Cross Branches were asked to send their proposals and also inform about existing policy. The proposals were received from 17 districts.
- (b) A committee at the State Branch consisting of Deputy Secretary, Senior Field Officer and Superintendent Establishment was constituted to examine the proposals received from districts to compile them and work out a common draft policy.
- (c) The proposal was worked out by the Committee and sent to the Punjab Govt. for consideration and further necessary action.
- 3. Now, the Punjab Govt. has returned the draft policy and conveyed vide its letter No. 4/77/2014-3f; 4/589402/1 dated 16.09.2015 that this draft policy may be got approved from the Competent Authority and issued to the District Red Cross Branches.
- 4. This policy is submitted for favour of approval of Managing Body as per provision under Section 27(x)and 34 of the Constitution of State Branch of Indian Red Cross Society. Section 4 of Model Constitution of District Red Cross Branches also states clearly that District Red Cross Branches are required to honour and observe all Rules and Regulations framed by State Branch. This uniform policy will be made applicable after its approval by Managing Body and will be issued to all District Red Cross Branches of the State for compliance.

Any Other Items

Revive of Junior Red Cross Subscription.

Upto 2008, all the students of all the classes of Govt. and Aided schools were associated with Red Cross Association and they used to contribute towards Junior Red Cross Fund which was quite nominal.

Consequent upon the implementation of RTE Act – 2009, education upto middle class has been made free. This necessitated discontinuation of Red Cross subscription from the

The matter was discussed and the Hon'ble Education Minister, Punjab explained that there are some categories of students who have been exempted

Government The will be requested sending by the copy of the proceedings of the meeting. After receipt of the decision from the students up to middle class. But in Punjab, this subscription has been stopped not only for the students upto middle class but also the students of 9th to 12th class. As a result of this, there has been a loss of income to Red Cross and students got dis-associated with the spirit of Red Cross.

In some State including the neighboring State of Haryana, the students from 9th to 12th class of the schools are still associated with Red Cross and making contribution to the Red Cross.

The Hon'ble Education Minister, Punjab may be requested to revise the decision and include the students from 9th to 12th class for making the contribution to the Red Cross.

payment of fees in classes higher than 8th. It was also opined that atleast those categories of students who are not getting any fee exemption can be included to make contribution towards Junior Red Cross subscription whereas for the other categories of students who are exempted from paying fees, it can be made voluntary discretionary.

The Hon'ble Education Minister stated that he broadly agrees with the proposal and assured that appropriate decision will be taken in the matter.

Government, the Schools will be approached accordingly.

In his presidential remarks, His Excellency the Governor, Punjab desired that the Red Cross volunteers, Social Workers and other NGOs should come forward to implement the welfare schemes of the Govt. because it is not possible for the Govt. to reach every strata of the Society.
