In the Punjab State Red Cross, 11 posts (02 regular & 09 contractual posts) of the Drivers are sanctioned and there is a provision in the Rules of the Society. On receipt of 02 ambulance vans from the SGPC, Amritsar and purchase of one funeral van (auto Hearse), 03 posts of drivers were got created after obtaining approval from Principal Secretary to Governor, Punjab-Cum-Chairman, Finance Committee, Indian Red Cross Society, Punjab State Branch in anticipation approval of Finance Committee. The item was placed before the Finance Committee Meeting held on 10th Mar 2015 for ex-facto approval which was approved by the Finance Committee.

Thereafter, during celebration of Bhai Ghaniya Day at Anandpur Sahib on 25th & 26th Sep 2014 by the State Branch, the representative of SGPC while preside over the function, assured that 02 ambulance vans will be donated to Indian Red Cross Society, Punjab State Branch by SGPC. In anticipation of the receipt of these ambulances, it was proposed to create two more posts of drivers to ply these ambulances. Accordingly, the proposal was placed before the Finance Committee meeting held on 10th March, 2015

AGREEMENT OF LEASE REGARDING REGIONAL TRAINING CENTRE (RTC) BUILDING

In order to increase the regular income of Punjab State Red Cross Branch, a Committee of Experts, headed by Mr. Rajan Kashyap, Ex-Chief Secretary, Punjab and the then Chief Information Commissioner, Punjab, was constituted in the Managing Body Meeting of Punjab State Red Cross held on 01.12.2005 (Annexure 'F') under the Presidentship of General (Retd.) S.F. Rodrigues the then Governor of Punjab and President of Indian Red Cross Society, Punjab State Branch. One of the recommendations of the Agenda item of the Committee was related to the utilization of vacant space available in the Campus of Punjab State Red Cross. The Committee proposed that additional building be constructed there and this building was proposed to be utilized, jointly by the Red Cross for meetings its requirements for space for training activities and the remaining additional space available to be utilized for accommodating the office of Punjab State Information Commission and the rent received from the State Information Commission would improve the financial health of the Society and it would become independent to carry out the main activities according to their aims and objects.

The project passed through many stages and ultimately has reached its logical conclusion on April 2017. The building including internal partitions have been completed and the office of SIC, Punjab has shifted to the rented portion of the building. The decision of rent rate has

- 3. The Punjab Govt. had provided a Grant-in-Aid of Rs. 4,98,29,000/- for the construction of the said building. But later on Punjab Govt. through letter No. 2/40/2006-1prs/903572 dated 04.01.2017 conveyed that Grant-in-Aid of Rs. 4,98,29,000/- which was provided to Punjab Red Cross for construction of RTC building at Red Cross Bhawan, Chandigarh is to be recouped from the rent of the RTC building. The issue was raised by the Punjab State Red Cross Branch and a meeting was held on 06.04.2017 under the Chairmanship of Sh. N.S. Kalsi, IAS Additional Chief Secretary, Governance Reforms to sort out the issue. It was decided in the meeting that this grant will not be recouped as this was given as Grant-in-Aid to Red Cross.
- 4. The decision about the rent of RTC building was also finalized in the meeting held on 06.04.2017 and the decision of the meeting has been approved by Hon'ble Governor, Punjab and President, IRCS, Punjab State Branch.
- The Lease Deed has been prepared and signed by both the parties i.e. Secretary, Indian Red Cross Society, Punjab State Branch (FIRST PARTY) and Secretary, State Information Commission, Punjab (SECOND PARTY) on 29.06.2017 (Annexure 'G') and it was mutually agreed that the annual increase in rent will be as per Punjab Govt. instructions as applicable for periodical revision of rent for building hired by the Govt. Departments/Boards/Corporations for office accommodation.
- 6. In this way, the Project, the seeds of which were laid in 2005, has reached its logical conclusion to the advantage of Punjab Red Cross as its vacant land stands utilized and a regular source of income by way of the rent has been created and the additional space has been made available for Red Cross related trainings. This could be made possible with the efforts of Sh. M.P. Singh, IAS, the then Principal Secretary to Governor, Punjab-cum-Chairman, Finance Committee, Indian Red Cross Society, Punjab State Branch, the cooperation extended by Punjab Govt., U.T. Administration and above all the blessings of His Excellency, the Governor, Punjab and President of Indian Red Cross Society, Punjab State Branch.
- 7. The status report and the Lease Deed agreement is placed before the House for approval & ratification.

AGENDA ITEM NO. 6

RATIFICATION OF FINAL DECISION TAKEN REGARDING APPLICABILITY OF E.P.F. AND MP ACT 1952

The employees of the Indian Red Cross Society, Punjab State Branch have remained exempted from the implementation of EPF Scheme so far. But it has now been intimated by Employees' Provident Fund Organization, Chandigarh that the said exemption has been withdrawn.

- Instead of EPF Scheme, the Punjab Red Cross Society has been giving the benefit of CPF to its employees according to which 12% of Basic Pay + D. A. is being deducted from the pay of the employees and the same share of contribution is being deposited in employees Account by the office. This is done as per resolution passed in the Finance Committee Meeting held on 26.06.2001 (Annexure 'H'). However, no such benefits are available to the contractual employees who have been demanding that they should also be given benefit either CPF or EPF Scheme.
- The Regional Office of Employees Provident Fund Organization, Sector-17, Chandigarh vide their letter No. RO/CHD/C-IV intelligence-Misc./1496 dated 09.03.2017 (Annexure 'I') has written to this office that the Central Govt. in exercise of its powers under section 16(2) of the Employees Provident Funds & Misc. Provisions Act 1952 exempted from the operation of the Act to certain establishments fulfilling terms & conditions as specified in Notification No. SO/1431 dated 14.05.2010 upto 31.03.2015 (Annexure 'J'). Now the Centre Govt. has decided not to extend the grant of exemptions to these establishments and consequently, all such establishments have come under the preview of the Act w.e.f. 01.04.2015. The Employees Provident Fund Organization is requesting times and again to extend the social security benefits, under the Act to all eligible employees of the Red Cross Society engaged either directly or through contractor w.e.f. 01.04.2015.
- Recently, we have received another letter No. Compliance Wing-A/1302 dated 13.03.2018 contents of which are reproduced as under:-

dated 16.05.17 vide which you were requested to extend the benefits to all the eligible employees under the EPF & MP Act-1952 but no action in this regard has been undertaken.

You are once again requested to extend the benefits to the employees and intimate the PF Code Number failing which this office would under take forced coverage of your establishment. Reply in this regard must reach within 7 days from the receipt this letter otherwise action may be taken against your establishment as per Rules".

- 5. To implement this Scheme of the EPFO to all the eligible employees (Regular & contractual) of the Punjab State Red Cross Branch, this issue was placed before the Finance Committee Meeting held on 22nd March, 2018 for its consideration. The Finance Committee has recommended that in principle, we should follow the relevant rules in this regard and adopt the EPF Scheme. It was further decided that this issue may be placed before the Managing Body of the State Branch for its consideration and approval. In case of ratification / approval, an additional part time professional consultant may be specifically hired on honorarium basis for maintenance of its records if so required.
- 6. The scheme may be implemented to the Punjab Red Cross employees w.e.f. 01.04.2018.

AGENDA ITEM NO. 7

ADOPTION OF AMENDMENT IN RULES DONE BY PUNJAB GOVT

One of the salient features of the Red Cross Society is that it is an independent and autonomous body which can have its own Rules / policies and guidelines for its administrative functioning. The Society however generally follows Punjab Govt. rules in service matters after its approval from the Managing Body which is competent authority to adopt/not adopt, fully or partially or modify such rules in the best interest of its own needs and requirements before adoption in Red Cross Society.

2. Recently the Punjab Govt. has taken some decisions regarding service matters which are placed before the Managing Body for its consideration and adoption which are given as under:-

(A) ENHANCEMENT IN THE PROBATION PERIOD

In Para 9 of the Indian Red Cross Society, Punjab State Branch Services & House Allotment Rules, 1996

amended upto 14.06.2016 and in column 11 of the Appendix 'A' of Service Rules, there is a provision of two years probation period for a person recruited by direct appointment. The Govt. of Punjab, Department of Personnel had amended the Punjab Civil Services (General & Common Conditions of Service) Rules, 1994 amended upto 30.09.2016 (Annexure 'K'), the probation period for the direct appointment has been increased from two years to three years.

As such Punjab Govt. Rules & Regulations are followed by the Punjab State Red Cross Branch. In view of the above, amendment is required in the Para 9 of the Indian Red Cross Society, Punjab State Branch Services & House Allotment Rules, 1996 as above and in the column 11 of Appendix 'A' of Service Rules.

DIRECT UPPER AGE LIMIT FOR **APPOINTMENT**

In Para 6 of the Indian Red Cross Society, Punjab State Branch Services & House Allotment Rules, 1996 amended upto 14.06.2016, there is a provision that the upper age should not be more than 35 years. Now the Govt. of Punjab, Department of Personnel had amended the Punjab Civil Services (General & Common Conditions of Service) Rules, 1994 amended upto 30.09.2016 (Annexure 'L'), the upper age for direct appointment has been made 37 years.

CAREER ASSURED **GRANT** OF (C) PROGRESSION SCHEME

The employees of Punjab State Red Cross Branch are given the benefit of Assured Career Progression Scheme according to the instructions issued by Department of Finance, Punjab Govt. vide letter No. 7/60/2006-5PP1/15863 dated 03.11.2006.

Now the Finance Department of Punjab Govt. has issued instructions vide letter No. 23/6/2016-4FP2/01 dated 01.01.2018 that the case regarding ACP benefit has been sent to 6th Pay Commission for its report. But in the mean time, the Govt. has decided that only the benefit of one increment be given to the employees instead of grant of next higher scale/Grade Pay.

AMENDMENTS IN RULES TO REMOVE ANOMOLOUS SITUATIONS.

(A) <u>REGULARIZATION OF THE POST OF ASSISTANT STATE TRAINING SUPERVISOR (ASTS)</u>

- (a) In the Service Rules of the Indian Red Cross Society, Punjab State Branch and allied bodies, 1996 amended from time to time, the post of State Training Supervisor (STS) is to be filled by promotion from the feeding cadre post of Assistant State Training Supervisor (ASTS). But the post of ASTS has been made a contractual post vide Punjab Raj Bhawan Note dated 24.04.2008 (Annexure 'M') duly approved by the then His Excellency, the Governor, Punjab and President of Punjab State Red Cross Branch. In this way, it creates an anomaly. The post of STS will always remain vacant if this decision for making the post of ASTS as contractual is not changed.
- (b) Keeping in view the above situation and the importance of the First Aid Training, it is of paramount importance that the post of ASTS be made regular so that this anomaly is removed.

(B) FILLING UP THE POST OF STATE TRAINING SUPERVISOR (STS) EITHER BY PROMOTION OR BY DIRECT RECRUITMENT.

As per provision in Column 8 in Appendix 'A' of the Indian Red Cross Society, Punjab State Branch, Services and House Allotment Rules, 1996 amended from time to time, the post of STS will be filled from the post of Assistant Training Supervisor having 10 years experience as such. It is widely being felt that the Disaster Management courses being taught in some Universities can be very useful in providing relief at the time of any disaster. Since Red Cross Society and St. John Ambulance remain in the forefront of providing such relief in disaster, therefore, this subject of Disaster Management is being useful and relevant for Red Cross employees especially those associated with First Aid Training. Therefore, it would be better if due weightage is given to those candidates who have got qualification in disaster management. Similarly those candidates who have become qualified Lecturer in First Aid and Home Nursing Training should also be very useful in Red Cross. Therefore, it is proposed that these categories be suitably included among the qualifications required for the posts of Assistant State Training Supervisor (ASTS) & State Training Supervisor (STS) in direct recruitment. RULES FRAMING FOR BETTER TRANSPRENCY

As provided in the Service Rules of Punjab Red Cross Society the Competent Authority for filling up the posts of various categories have been indicated. It has been generally noticed that almost all the appointments in the Punjab Red Cross on regular basis have been made through promotion or on compassionate grounds or from among the contractual employees already serving in the Society, from time to time. Since the inception of Society to date, it is also observed that though the employees on regular as well as contractual basis may have been appointed by the Competent the Authority, keeping view in needs/requirement of the Society. However, there is no clear policy or guidelines yet available in black & white in this regard. It is felt that it may be better to frame clear guidelines and policy for the sake of more transparency, objectivity and fair play. For this purpose a sub committee of experienced officials of Red Cross was constituted which after considering all aspects of the matter has submitted its recommendations (Annexure 'N'). The employees working in these projects/schemes are generally low paid and are employed as per norms of the sponsorers. In case any project/scheme is closed at any point of time or if any vacancy in the Red Cross is vacant and available to be filled then the employees working in said Projects/Schemes can be re-employed on priority in Red Cross provided that he/she fulfills all the requisite educational qualifications, age & experience as per Society Rules. The case of such employees may be considered sympathetically keeping in view the overall interest and financial health of the Red Cross Society.

AMENDMENT IN RULES TO REMOVE STAGNATION

It has been observed that the cadre of regular employees serving in Punjab Red Cross is very small and it is further shrinking due to the retirement of many officials in recent years. The Senior Officers serving on the posts of Superintendent Grade-II, Social Welfare Officer, Publicity Officer and Field Officer have been retired and these posts are remained unfulfilled for long period due to non availability of eligible employees and small promotional cadre of the Society. We have experienced employees who are working as Senior Assistants on regular basis could not be promoted due to long experience required for these posts. Therefore, it is proposed that the experience required for senior categories of posts i.e. Superintendent Grade-II, Social Welfare Officer, Publicity Officer and Field Officer may be reduced to 5 years instead of 8 years because it would be a more rational and balanced decision under the circumstances. This will also provide a reasonable opportunity for promotion to concerned categories of employees and will help to remove the sense of stagnation and frustration which will also be in the interest of the Society and the employees because these employees have been promoted to the post of Senior Assistant after a long gap of more than 15-20 years due to small promotional cadre.

2. In view of the situation explained above, it is proposed that the eligibility criteria for the post of Superintendent Grade-II, Social Welfare Officer, Publicity Officer and Field Officer may be revisited and amended as under:-

For: "From amongst Senior Assistants and Senior Scale Stenographer (designated as Personal Assistant) having 8 years experience as such"

Read: "From amongst Senior Assistants and Senior Scale Stenographer (designated as Personal Assistant) having 5 years experience as such"

- "1. The provision of Earned Leave may be made in Service Rules as per the Rules of Red Cross State Branch Employees.
- 2. Contributory Provident Fund (CPF) may also be made applicable @ 12% on Basic Pay + DA as is being done in case of employees of Punjab Red Cross State Branch instead of 10% given in existing Rules."

Matter is being placed before the Managing Body for consideration & approval.

(B) <u>CLARIFICATION REGARDING IMPLE-MENTATION OF UNIFORM SERVICE RULES FOR DISTRICT RED CROSS BRANCHES</u>

Rules of the District Red Cross Branches were approved by the Managing Body of the Indian Red Cross Society, Punjab State Branch in its meeting held on 14 Jun 2016. It has been observed that there seems to be some confusion in some District Red Cross Branches regarding the date from which these Rules are to be implemented. In this regard, the following clarifications may be given:-

- a) The rules framed for the District Red Cross Branches will be effective from the date of approval i.e.14.06.2016 by the Managing Body of Indian Red Cross Society, Punjab State Branch.
- b) The District Red Cross Branches are advised that as a matter of natural justice no rules be implemented with retrospective effect if it is detrimental in any way to the cause or interest of any concerned employee/employees on which it is applied.

AGENDA ITEM NO. 12

REGARDING ADOPTION OF UNIFORM RULES FRAMED BY NATIONAL HEADQUARTERS FOR STATE /UT/DISTRICT BRANCHES

The uniform rules were framed by the National Headquarters of the Indian Red Cross Society for the State/UT/District Branches. After its approval by the Hon'ble President of India-cum-President of the Indian Red Cross Society, these were circulated by the National Headquarters to all the State/U.T. Branches with the request for its implementation. In Punjab State these were received vide letter No. N/12017/1/09/DISS/9772 dated 02.09.2009 which was directly addressed to His Excellency the Governor of Punjab-cum-President of IRCS, Punjab State Branch. These rules were examined at the office of the Secretary to Governor, Punjab and it was found that these rules can not be implemented in Punjab in toto as these are in extreme variations from the Constitution of the State Branch. The observations made by the office of the Secretary to Governor, are reproduced as under:-

> letter "Please refer your to 12017/1/09/DISS/9486 dated 02.09.2009 on the subject cited above.

- The Uniform Rules circulated by the National Headquarter have been perused. It may be pointed out that Punjab State Branch of the Indian Red Cross Society has its own Constitution duly approved in the Annual General Meeting. As such it may not be possible to implement the rules sent by National Headquarters in toto, as there are certain extreme variations in the uniform rules from the existing provisions in the Constitution of the State Branch. The Paras which are at variance with the existing provisions as per Constitution of the State Branch and the suggestions are being enclosed. The National Headquarters may go through the suggestions on merit and consider amendment in the uniform rules before they are placed before the Annual General Meeting of the State Branch for adoption."
- The issues about which the office of the Secretary to Governor, Punjab has expressed disagreement vide their Endst. No. PRB-EA-10/472 dated 21 Jan 2010 (Annexure 'R') pertains to the following:

Later this office also received a letter No. N.12017/01/09/Diss. Vol.-II dated 04 Nov 2011 from Indian Red Cross Society, National Headquarters vide which they have intimated that after considerable deliberations decided to extend the time for implementation of uniform rules till 31.12.2011 (Annexure 'S').

It is not out of place to mention here that there are some other States/U.T. also which have not adopted these rules in toto vet.

The issue regarding implementation of Uniform Rules is being discussed at National Headquarters in various meetings. This office has also written a letter No. NMB /Rules/State and U.T./YRC/4564 dated 02 Feb 2018 (Annexure 'T') to Indian Red Cross Society, National Headquarters with the request to consider the suggestions already given by the office of Secretary to Governor, Punjab and further clarified the logic and reasons behind the position taken by Punjab State Branch.

No response has been received from National Headquarters to these objections raised by the office of Principal Secretary to Governor, Punjab, Punjab Raj Bhawan, Chandigarh so far.

It is felt that it may be a good idea to have Uniform Rules for the whole Nation. Yet the exercise of framing such rules needs to be done in more intensive and extensive manner which may include comprehensive discussions and meetings, with representatives of all the concerned States & U.T. Branches.

The entire position and status is placed before the House for its kind information.

We have not received any response from National Headquarters regarding our letters and suggestions. It is, therefore, proposed that we may reiterate the position taken in this regard by the State Branch and inform about the decision to National Headquarters. In the meantime status quo may be maintained.

His Excellency, the Governor, Punjab and President of Punjab State Red Cross delivered his presidential remarks:-

Presidential Remarks :-

I am pleased to see that this meeting of Managing Body of Red Cross & its allied bodies have been successfully concluded today and some important decisions pertaining to Governance of the State Branch as well as the District Branches have been taken unanimously which I hope will help in improving the functioning of State & District Branches of Red Cross.

- 2. We have also noted the activities pertaining to service of humanity which are being undertaken by Punjab Red Cross and many of its achievements. The performance of the Red Cross in Prevention of TB, Prevention of AIDS & HIV Project and in Drug De-addiction is appreciable.
- 3. I am very happy to note that Punjab Red Cross and St. John Ambulance, Punjab State Centre has made a huge progress in First Aid Training. The importance of First Aid Training can not be over emphasized in any society or for any individual. Therefore, I wish that this campaign is further carried to the district level and even still further to the ground level by the Deputy Commissioners. For this purpose, all Deputy Commissioners should work out a time table for imparting training and make adequate arrangements in each district. The campaign may be carried out in educational institutions, industries, Jails, various departments of Govt. and in fact all sections of Society.
- 4. Training for Disaster Management is another area where Red Cross can play a key note. DCs must utilize the platform of Red Cross to train all the stakeholders in disaster management activities.
- 5. On the whole, I am pleased that Punjab Red Cross is doing a very good job and the State Branch and the District Branches are also playing their roles in mitigating the sufferings of humanity through their various projects.

6. However, times are fast changing and institutions like Red Cross have to reinvent themselves if they are to retain their relevance for the modern requirements of the Society. This will not only require

re-orienting the activities to be taken up but also revisiting the rules and regulations of Red Cross to make it more flexible, effective and transparent to build the confidence of the Society.

- Red Cross can not directly take up all social activities. Instead, Red Cross with the advantage of DCs' as Chairman should encourage and facilitate the involvement of large number of volunteers. voluntary organizations who can have positive influence on the people. Internet based mobile applications should be used to involve and engage volunteers in a large number of voluntary activities in the districts.
- I am happy to see so many DCs' and Divisional Commissioners assembled here today. I don't 8. get many formal opportunities to meet the DCs. So I take this opportunity to flag a few areas of critical importance for the State where you all need to play a pivotal role.
- Agrarian issues in Punjab have assumed critical proportions and have to be resolved 9. sustainably. Unsustainable depletion of ground water, excessive use of chemicals and fertilizers, poor soil quality, paddy straw burning, farmers' suicides are all issues which need our urgent attention. A strong, democratic and market oriented institutional set up of farmers is the foundation for resolving Organizing farmers in Farmers' Producer Organizations (FPOs') and many agrarian issues. Companies are providing beneficial in terms of lower costs, better price realization, crop diversification, taking up supplementary non farm activities, micro irrigation, convergence platform for all schemes. DCs should spearhead the district level initiatives to form more FPOs and strengthen them for farmers' welfare.
- Another area, which will assume critically in this coming paddy season, is the paddy stubble 10. burning issue. Government of India has sanctioned a special scheme for Punjab with an outlay of Rs. 269 CR for the current year to tackle this issue. This amount is to be used for subsidizing machinery and equipment like happy seeders, used while avoiding paddy straw burning. But what is of critical importance is convincing the farmers of the sustainability of the alternate options by which they can avoid stubble burning. There is a good amount of about Rs. 30 CR earmarked only for IEC activities. DCs must lead the initiative in putting together an effective awareness generation plan and coordinate the implementation by being active and visible part of the campaign.
- Starting from 2nd Oct 2018, this entire year is being celebrated to commemorate the 150th Birth 11. Anniversary of Mahatma Gandhi, who was the epitome of voluntarism who moved an entire nation to fight for its freedom. I urge the DCs to formulate and implement an impactful year long plan of events and programs in their districts, to commemorate and spread the relevance of Mahatma Gandhi's ideals.

I convey my best wishes to all of you.

In the end, Sh. C. S. Talwar, IAS (Retd.), Secretary, Indian Red Cross Society, Punjab State Branch thanked His Excellency the Governor, Punjab, Hon'ble Health Minister, Punjab, Hon'ble Chief Secretary, Punjab and all the members and also requested the members to shift to the auditorium hall of MGSIPA where the next meeting i.e; Annual General Meeting will be held under the Presidentship of His Excellency after 10 minutes.
