Sub: Approved format of Bio Data for Vice-Patron/Patron and Application Form for Membership.

Dear Sir/Madam,

You are well aware that Indian Red Cross Society is a membership based organization. Enrolment of members in different categories is a major source of fund raising.

As per Rules for State/UT/District Branches, members can be enrolled at the district or sub-district levels. State branches shall enrol members only when the local district branches are not constituted. However, State/UT Branches can enrol members after obtaining explicit permission of the National Managing Body.

At present, the National Headquarters issues following categories of membership certificates to the individuals on the recommendations of the State/UT Branch/Leadership Managing Committee of the concerned Branches:-

- 1. Patron.
- 2. Vice-Patron
- 3. Life Members
- 4. Life Associates
- 5. Institutional Members (Annual)

The Membership & Fundraising Committee in its meeting held on 10.2.2021 decided that the application form and bio-data for seeking membership of IRCS should be amended. Based on their suggestions application form & bio-data proforma have been amended.

The State/UT branches are requested to inform District branches to enrol members on the basis of format enclosed.
